2000 CONVENTION KEYNOTE SPEAKERS

DR. GERALD L. SHOOK is the Executive Director and Secretary of the Board of Directors of the Behavior Analyst Certification Board. Dr. Shook has been instrumental in establishing behavior analysis certification programs in several states and now on the national level. As we consider taking the steps towards recognizing behavior analysis certification in Maryland, Dr. Shook will discuss the state-level implications of certification for practitioners and the individuals we serve. Immediately after Dr. Shook's presentation, there will be a discussion for those individuals interested in behavior analyst certification in Maryland.

DR. BRIAN A. IWATA is a Professor of Psychology at the University of Florida and the Director of the Florida Center on Self-Injury. Dr. Iwata has published over 175 articles and chapters in the areas of applied behavior analysis, developmental disabilities, program evaluation, and staff management. Much of Dr. Iwata's research has focused on the functional analysis of severe behavior disorders. This approach to assessment and treatment is one of the most significant advancements in behavior analysis over the past 20 years and is now considered the standard in the field for both clinical research and practice. Dr. Iwata will be presenting a talk entitled "The Current Status of Functional Behavioral Assessment in Research and Practice."
